- **3. MOTION** Regarding the LA City Planning Dept proposal to eliminate site plan reviews for construction of 100% affordable housing of 50 units or greater (under current code no site plan review is required for under 50 units). This is a link to the (very brief) draft ordinance:

The Community Forest Advisory Committee foresees potentially serious tree canopy decline with the implementation of CPC-2023-1083-CA. By waiving Site Plan Review for larger affordable housing construction, it would eliminate environmental reviews. The City has spent time and money on an environmental justice tree equity study:

https://laurbanresearchcenter.org/wp-content/uploads/2021/02/LAUF-Equity-Assement-Report-February-2021.pdf which demonstrates that our city has very low tree canopy in what are considered lower income areas, compared to more affluent neighborhoods where the city's overall tree canopy is concentrated.

It has been our observation that developers/contractors generally remove property trees, eliminate street trees, and often relegate new tree planting to rooftop planters. Bypassing all environmental review could eliminate any current due process for existing trees. Are we dismissing the Protected Tree Ordinance, UFD's public tree removal notifications, Board of Public Works hearings for the removal of more than two street trees or protected trees, and the Planning Department's judgments to require replacement planting for some significant tree removals?

Waiving Site Plan Review for new affordable housing potentially contributes to greater tree and shade inequity. Because new trees take several decadesyears to mature, we should be cautious not to further accelerate our declining canopy, especially in lower income neighborhoods, as this makes our city less livable as we add structures.

Ideally, to promote canopy equity, affordable construction should require a design, even a dedication, that accommodates 10 foot parkways, the size required by Urban Forestry to plant native tree species like the coast live oak, which maximize tree canopy and contribute immensely to biodiversity. Planting these large native trees has proven health benefits for residents and would provide shade that keeps air conditioning costs down and attract birds that have a calming effect on the neighborhood. The City Council adopted a biodiversity directive in 2022 and LASAN is working with City Departments to further biodiversity goals -- their reports are listed here:

We must not contribute to environmental *injustice* with new affordable housing.

Furthermore it is also risky to set aside environmental considerations for affordable housing because it leaves open a parity issue, such that all developers will want environmental considerations bypassed for all projects and predictably would sue to get this. Please do NOT eliminate important Site Plan Reviews, which are meant to improve projects.
